

2021-2022 Troop MN-2950 Registration Fees and Program Costs

The following is a breakdown of initial and annual costs. Please note these costs are subject to change annually.

TRAIL LIFE USA NATIONAL REGISTRATION FEES

Student Member Registration

- *\$30.70 (annual) Membership Registration – Paid directly to Trail Life USA by family each year per student.*

Adult Member Registration

- *\$35.68 (annual) Membership Registration – Paid directly to Trail Life USA by adult volunteers each year through www.TrailLifeConnect.com online account. One adult per family must register.*

TROOP MN-2950 REGISTRATION DUES

Annual Troop Dues is up to \$60 per student per year (Includes badges, Patrol supplies, some camping supplies, crafts and other supplies, and general office supplies).

- *\$60 Joining Fee (Troop 2950 Dues)*
- *\$50 Annual Fee due in the Fall of each Program Year (Aug-Jul)*

Trailman Handbook

- *Trailman Handbooks are provided. Cost for lost handbook \$20 (as needed)*
 - *One book for Woodlands Level – Grades K-5 (keep same book all 6 years)*
 - *One book for Navigator and Adventurer Level – Grades 6-12 (keep same book all 7 years)*

Trailman Uniform Shirts

- *Trail Life t-shirt provided at joining – Used for special events where uniforms are not needed*
- *\$45 (as needed) – Same shirt is used Grades K-12, but the boys will outgrow their shirts at some point. To save shipping expense, purchase through the troop.*

Special Events (optional)

- *Additional charges vary based on activity.*

How to pay

Payments for dues, donations to the troop, and payments for other expenses are collected through the Trinity Lone Oak Lutheran Church website Giving link. We request you pay online for these items.

1. Go to www.trinityloneoak.org and select Giving from the task bar. You **must** complete a **separate transaction** for each Trailman.
2. At this time, there is no online cart. Please know the amount due before you make your payment. Choose "**Give Now**" under Create a Login Profile.
3. Under "Contributions – Trail Life USA Troop 2950", fill in the amount of your payment, Type the Name of the Troop Member in the text box. **Trail Life dues are not tax deductible.**
4. Send an email to the Troop Treasurer to let them know how to account for your payment. The troop email address is troop2950@trinityloneoak.org;
5. There are three items you may include in your payment:
 - **Local Dues** (everyone should pay)
 - **Troop Standard** (only Navigators & Adventurers who haven't purchased already)
 - **Handbook** (only Trailmen who have lost their book)
 - **Other items you would like TLO to order for you from the Trail Life Store.**
